He holds a faculty appointment at Harvard Medical School.

Nancy E. Norman, MD, MPH

Medical Director of Integration, Massachusetts Behavioral Health Partnership (MBHP)

Dr. Norman, a native Bostonian, is the medical director of integration for the Massachusetts Behavioral Health Partnership, a Beacon Health Options (Beacon) company. She has served in this role for nine years, focusing mainly on working with city and state public health officials, medical providers, consumer advocates, and business leaders to improve health outcomes by working to improve healthcare systems. She brings a keen appreciation of the interdependency of medical, behavioral, and social dimensions of health to a career spent implementing actionable, practical strategies for health improvement and system redesign. The major focus of her work is to look at ways to better integrate behavioral health with primary care, partly by focusing on payment reform and health system redesign efforts.



Madhuri Jha, MPH, LCSW

Director, Kennedy-Satcher Center for Mental Health Equity

Madhuri Jha, MPH, LCSW is a clinical social work and public health professional with experience providing leadership, training, consultation and direct clinical practice to programs focused on health equity, behavioral health systems strengthening, trauma and resiliency, mental health epidemiology and community capacity building. She currently serves as the Director of the Kennedy-Satcher Center for Mental Health Equity, an entity of the Satcher Health Leadership Institute at the Morehouse School of Medicine, where her work focuses on leading national discourse, programming and research about embedding equity into policies and services that reach people living with behavioral health concerns. Ms. Jha is also a practicing psychotherapist in private practice with specific expertise in trauma and stressor-related disorders, psychosis, acute symptom management, cognitive behavioral therapy, risk assessment and de-escalation.



Kevin M. Simon, MD

Inaugural Chief Behavioral Health Officer for the City of Boston

Dr. Simon is the inaugural Chief Behavioral Health Officer for the City of Boston, appointed by Mayor Wu. Through the Boston Public Health Commission, he will guide a public health strategy to support Boston's growing mental and behavioral health needs. Dr. Simon is a child, adolescent, and adult psychiatrist, an addiction medicine specialist, and a physician-scientist at Boston Children's Hospital. He is an instructor of psychiatry at Harvard Medical School and a health policy fellow at Harvard University. Clinically, Dr. Simon primarily treats and cares for patients through the Adolescent Substance Use & Addiction Program at Boston Children's Hospital. In addition, he is proud of providing psychiatric services, including direct patient care and consultation, to several state psychiatric facilities and behavioral health organizations.



Shavonne J. Moore-Lobban, PhD, ABPP

Campus Director of Training, The Chicago School of Professional Psychology

Shavonne J. Moore-Lobban, PhD, ABPP, is a board certified counseling psychologist who focuses her career on providing high quality services to marginalized populations, and training future psychologists to do the same. She is currently the Campus Director of Training at The Chicago School of Professional Psychology, Washington DC Campus, as well as the Director of the APA Accreditation internship entitled the Mid Atlantic Internship Consortium. Her clinical expertise is in trauma (sexual trauma, domestic violence, racial trauma, and community violence) and providing services to marginalized communities. She has developed curriculum on sexual and interpersonal assaults, has been called to participate in state's government efforts to reduce the demand of sexual exploitation, and was asked to provide support services to victims of the Boston Marathon Bombing federal court proceedings. She has coauthored multiple publications including a recent book on Black women and domestic violence, and another on child maltreatment and the Black community.



Debra A. Pinals, MD

Senior Medical and Forensic Advisor and Editor-in-Chief, National Association of State Mental Health Program Directors

Debra A. Pinals, M.D. serves as Senior Medical and Forensic Advisor and Editor-in-Chief for the National Association of State Mental Health Program Directors (NASMHPD), and as the Medical Director of Behavioral Health and Forensic Programs for the Michigan Department of Health and Human Services and is the Director of the Program in Psychiatry, Law, & Ethics and Adjunct Clinical Professor of Psychiatry at the University of Michigan Medical School and Clinical Adjunct Professor at the University of Michigan Law School. She has worked in outpatient, inpatient settings, forensic and correctional facilities, emergency rooms and court clinics, has received public service awards and has been an expert witness in many cases. She is Board Certified in Psychiatry, Forensic Psychiatry, and Addiction Medicine. Recently she has been a lead subject matter expert on issues pertaining to competence to stand trial for the SAMHSA GAINS Center. She conducts work as an expert witness and subject matter expert across the country.



Martin Henson, MS

Executive Director, BMEN Foundation

Martin is a speaker, trainer, activist, and organizer who has spent the last ten years advocating for Black lives, addressing the systemic issues that affect Black and marginalized groups through both conventional and unconventional avenues. His nonprofit (BMEN Foundation) builds support networks for Black men while addressing stigma related to mental health, masculinity, LGBTQ inclusivity, racism, and sexual violence. Martin uses his training as a mental health counselor to add nuance to the way we support the livelihood of Black people. He has done this through engaging thousands of people around prison abolition, fighting white supremacy, and supporting Black communities through seminars, training and curriculum development, community events, rallies, and activism.



Tanoy Burton

Founder and Executive Director, DeeDee's Cry Suicide Prevention and Family Support

Toy Burton is the Founder and Executive Director of DeeDee's Cry Suicide Prevention and Family Support. DeeDee's Cry is named after her sister, Denita Shayne Morris (DeeDee), who died by suicide when she was twenty-three years old, in 1986. Toy started DeeDee's Cry in 2017, after noticing organizations didn't have their events regarding mental health and suicide prevention in communities of color. Toy's organization, DeeDee's Cry, creates space and events to elevate the conversation about mental health awareness and suicide prevention in communities of color. Today, DeeDee's cry provides support to individuals and families impacted by suicide. Additionally, they collaborate with numerous organizations to develop community events and programming focused on mental health, family, and suicide prevention. Toy Burton is also the Founder and Executive Director of the Roxbury Unity Parade.
