- 8. Anthony and AJ need help to do quality activities and interactions with Tisha each week (7-28)

- 9. Tisha needs help to be successful in early care and education
- 10. AJ needs help to respect peers and not bully them (9-28)
- 11. Mariam has a need to stay clean from alcohol addiction
- 12. Mariam needs help to take care of Tisha so Mariam can go back to school and get a steady job she enjoys

The initial brainstorming focused on needs for more natural supports and more consistent communication so AJ could start overnights at LaRisa's and Anthony's. The plans are working. They find something to celebrate each night and the calendar shows they are doing this five or six times a week. The family has weekly "family meetings" and have only missed one week since this started in July. Overall, AJ, Anthony and Mariam report this is improving communication and reducing family stress.
October 27, 2010	X	The nightly discussions between Mariam and AJ continue and they have met as a family the last two weeks. They report general satisfaction with this process although AJ complained that when his grades started falling they were all in his face and mom is always on Anthony about his drinking. The family meetings were discontinued for the last three weeks but will start again this weekend. The team discussed lowering the objective but the family thought they could meet the objective. Mariam has met consistently with her new supports but prefers the one on one to the family group.
