- Meeting should start and end on time, be effective and last about an hour
- Everyone should have their say and everyone else should listen
- Team decision making: Tina says as long as safety concerns are met for Tisha, and Keith (AJs probation officer) says as long as plan meets probation plan for AJ; Mariam, Anthony and AJ will make final decisions, with team input
- Confidentiality: Keep personal business private, maintain confidentiality, what is said in meetings stays in the meetings, and team learns to trust each other

- 6. AJ needs help to find a school/vocational setting that he enjoys, and attend school regularly
- 7. AJ needs help to find and engage in more activities with people who will not tempt him to smoke marijuana or get into fights
- 8. Anthony and AJ need help to do quality activities and interactions with Tisha each week (7-28)

- 9. Tisha needs help to be successful in early care and education
- 10. AJ needs help to respect peers and not bully them (9-28)
- 11. Mariam has a need to stay clean from alcohol addiction
- 12. Mariam needs help to take care of Tisha so Mariam can go back to school and get a steady job she enjoys
- 13. Mariam has a sister nearby she would like to have a closer relationship with
- 14. Mariam and Anthony need help to continue family adjustment to the divorce

July 14, 2010				This was the first meeting which formalized family vision, team mission, ground rules and priority needs. A plan was developed to get Mariam and Anthony support to understand and parent Tisha based on brainstormed strengths, family culture and related options. Tisha has shown progress with control of her bowel movements with implementation of the initial crisis plan.		
July 19, 2010	X			Team members completed their action steps to find an early childhood specialist and Mariam choose Bruce Martin who attended the meeting today. He will start IHT two times a week next week.

The initial brainstorming focused on needs for more natural supports and more consistent communication so AJ could start overnights at LaRisa's and Anthony's. The plans are working. They find something to celebrate each night and the calendar shows they are doing this five or six times a week. The family has weekly "family meetings" and have only missed one week since this started in July. Overall, AJ, Anthony and Mariam report this is improving communication and reducing family stress.
October 27, 2010	X	The nightly discussions between Mariam and AJ continue and they have met as a family the last two weeks. They report general satisfaction with this process although AJ complained that when his grades started falling they were all in his face and mom is always on Anthony about his drinking. Mariam and Cara met with LaRisa and overall the meeting went well. It was a little tense to start but LaRisa already knew of Mariam's efforts and progress helping her kids through Nyrell and AJ. In the end they agrees they wanted to see each other more and LaRisa volunteered to provide some childcare for Tisha on a regular basis on a weekend day.

At first Tina's supervisor wanted to put Tisha in foster care. Laurie, Tina and Mariam met with her. Mariam apologized for causing such a disturbance but said she was protecting Tisha. It was agreed not to change her status but Anthony will only be able to have supervised visits. Keith questioned AJ and he admitted that his dad often drank when AJ was around. It was ordered that AJ could no longer stay at Anthony's apartment. Anthony talked to Samuel and said he wanted to do something about his drinking and Samuel suggested multiple options. Anthony also talked to Cara about AA and decided to try that first. He has attended two meetings with her. The family meetings were discontinued for the last three weeks but will start again this weekend. The team discussed lowering the objective but the family thought they could meet the objective. Mariam has met consistently with her new supports but prefers the one on one to the family group.
